## **Geriatric Medicine and Services on the NS**

At the May 25/11 Dine and Learn, Dr. Deviani Maher, Geriatrician and Phil Lawrence, Director of VCH - NS Seniors Services presented information about geriatric medicine and senior services on the NS. A copy of the PowerPoint presentation, referral form and a onepage summary of the presentation can be found under the "Resources" tab of our website.

Dr. Maher and Mr. Lawrence reviewed issues raised during the event dialogue with Dr. Dick Lupton, e.g., exam space at facilities, communication between Acute and Community and between facilities and GP offices. Mr. Lawrence will be following up on these.

#### GP Mental Health Planning Fee G14043 \$100.00

- Payable upon the development and documentation of pt's Mental Health Plan for care over rest of calendar year for pts who reside in the community (home or assisted living, excluding care facilities).
- Requires 30 minute faceto-face visit. If longer, bill office visit (up to 50 min) or counseling visit if meets preamble criteria (over 50 min) in addition.
- Billable once per calendar year (not necessary to be on anniversary of previous year – do when clinically indicated).

## **GP Billing Information Session**

Dr. Joanne Larsen presented GPSC billing information and billing updates to 70 GPs and MOAs during a dinner meeting on June 23, 2011 at LGH. Visit our website for a copy of the General Billing and Obstetrics Billing Power Points, handouts, and Q/A raised during the evening. In support of GP practices, GPs were compensated for MOA time spent at the session.

#### **Billing Pearls**

- The prevention billing code, **14066** is worth \$50 and can be billed 100 times in 2011 (once per patient only). Need to use specific diagnostic codes 783, 785 or 786.
  - **14043** is a time dependent billing (you must spend 30 minutes to bill it). If you spend 50 minutes, you can bill a 100 in addition. If you spend more than 50 minutes you can bill a **0120** in addition to the **14043**.

### **Division News Bytes**

- The Division recently learned, from the BC Ministry of Environment and Transport Canada, that <u>all</u> sharps disposal vendors require a license to transport hazardous/infectious waste, e.g., used needles, and weight exemptions <u>do not apply</u> to this waste. The Division received confirmation of licensure from two out of five vendors in BC. GPs are advised to follow up with their sharps vendors as the Division is not pursuing a sharps preferred purchase program.
- An Integrated Health Network pilot test case is underway where a NS VCH Case Manager is assigned to a GP to cover his patients who require case management. The GP and CM are exploring various methods of communication, e.g., weekly meetings; CM calling directly from a patient's home, etc. to determine the effectiveness of different approaches. Currently Case Managers are assigned by geographic district. More on this to come.
- If you and/or your colleagues have an idea you would like to explore regarding changes to a part of the health care system to make it more sustainable, Division funding is available to compensate you for your time. To find out more, please contact a Board member or the Division Coordinator.
